



Centurion & Supreme Boats, in conjunction with the Competitive Wake Surf Association, is proud to announce the criteria* to qualify for an invitation to compete in the **25th Annual World Wake Surfing Championship**:

Event Dates Live Venue: October 7 to 9, 2021. Module Venues: September 17 to 19, 2021.

- Athlete check in and registration – Electronic – Modules and Live venue Deadline: 3 days before Event.
- Mandatory Rider’s Meeting – Video – Deadline for Compliance: Two (2) days before Event (Modules and Live).
- Opening Ceremony: Each day of the Live venue event, specific time TBD.

Event Attendance & Competition Requirement **This event is Invitation only.** To qualify for an invitation to the most prestigious Wake Surfing event on the planet an athlete must attend and compete in the following minimum number of World Series of Wake Surfing events (Gold or Platinum Event Level), and the athlete’s Continental Championship event:

- Pro Skill Level Three (3) 2021 World Series of Wake Surfing events (Gold or Platinum Level), **and** the athlete’s 2021 Continental Championship. If the Continental Championship is a Gold or Platinum Level event, it will count as one of the required three (3) World Series events.
- All Other Skill Levels Two (2) 2021 World Series of Wake Surfing events (Gold or Platinum Level), **and** the 2021 Continental Championship. If the Continental Championship is a Gold or Platinum Level event, it will count as one of the required two (2) World Series events.
- There is no WRS Qualified event (Bronze or Silver Event Level) competition or attendance requirement, however, all WRS Qualified event points are included in the WRS Rankings.
- The Event Attendance and Competition Requirement may be met in any Skill Level during the 2021 season.
- If an athlete meets the Event Attendance and Competition Requirement for one Division in their Skill Level, the requirement will be met for the other Division in that Skill Level.

Invitation Criteria In addition to meeting the event attendance requirement, an athlete must be in the top WRS Ranked range in any below listed Division, as of the Qualification Cutoff Date.

Qualification Cutoff Date: **September 2, 2021.**

Invitations Send Date: **September 3, 2021.**

Declined Invitations

If invitation is declined for any reason, including a failure to timely register and pay the registration fee:

1. Centurion and Supreme Boats may, but is not required to, offer that invitation to the next ranked and otherwise qualified competitor in the Division in which the invitation was declined; or
2. Centurion and Supreme Boats may, but is not required to, allocate any declined invitation to any other Division, and invite the next ranked and otherwise qualified competitor in that Division.

***PLEASE NOTE**

Due to the COVID-19 global pandemic and the dynamic uncertainty of travel, event and public gathering restrictions, the Invitation Criteria, including the Event Attendance & Competition Requirement and the form of the event (Live, Modular, Online) for each skill level may be subject to change. The number of invited athletes compared to the 2020 competitive season in the Amateur, Outlaw, Masters Women and Juniors skill levels have been increased for **this year only** due to the hybrid Live and Module event format of this year’s World Wake Surfing Championship.
